- 3. 2015 Animal Care and Housing Agreement the 2015 Agreement for the SPCA was reviewed by the Board with \$1883.00 payment due from the Township. A motion was made by Clark to execute the agreement and make the annual payment. Dean seconded and the motion was passed.
- 4. General Municipal Pension The Commonwealth of Pennsylvania forwarded the allocation of \$3,872.68 to defray the municipality's pension costs.
- 5. Municipal Liquid Fuels The Township received notification that the 2015 estimated allocation amount will be \$138,753.70 and Road Turnback Allocation Amount is \$22,240.00
- 6. Klugh Animal Control Services Contract for 2015 with a \$250.00 annual fee was presented. Clark made a motion to execute the agreement and the annual payment. Dean seconded and the motion was passed.
