Fire Department Reports:

- 1) New Polling place – Paradise Evangelical Lutheran Church, 3241 Church RD, Thomasville , PA 17364

- 3) The April 2020 bill list was approved by Clark and seconded by Dean.

New Business:

- 1) Jonathan Schardt submitted his resignation letter from the Board of Auditors Dated April 15, 2020
- 2) Brittany Bathurst submitted her resignation letter as the Township Tax Collector dated May 1, 2020. Clark made the motion to accept and Dean seconded. The motion was carried by a unanimous vote.

- 5) Patrick Buhl was appointed the SEO and Hanover Land Services was made the Alternate. Hanover Land Services will honor Mr. Buhl's fee schedule. Clark made the motion to accept and Dean seconded. The motion was carried by a unanimous vote.
- 6) Windy Hill Senior Center sent a thank you letter for the contribution they received from the Township.

Recreation Park Discussion:

- 1) The Farmer's Fields Park was vandalized. There was a broken bench and a section of the Playground equipment was dismantled in a manner that appeared it was done to cause harm or injury to a child. The bench and equipment were repaired.
