- 2) Information on new recycling bag restrictions...Lance Biesecker and Elwood Miller presented information concerning a phone call the Township received from Republic Services saying AI cameras were installed in the Recycling Trucks and that we would be charge a \$75.00 penalty per bag for any plastic bag identified by the AI system. Mr. Biesecker said we have out digital signs flashing the information and new permanent signage is being made to show acceptable items per the newest information we received.
