8. New Business:

A. Superior Homes - Orchard Road (Plan Expires: September 7, 2019)

Clark Craumer presented a revised plan for Superior Homes on the south side of Rte. 30 and Orchard Road. Originally, this property was to be used to store manufactured homes for the Superior Homes sales lot across Route 30 to the north. The new plan was presented to the PTPC as a Minor Plan whereby three (3) parcels were being joined together. As this plan now proposes to add a structure, it becomes a Land Development Plan and needs to meet the requirements of such a plan.

The impervious boundary was discussed at length but there was agreement that the new plan properly delineates this boundary. The entrances were also discussed; especially one off of Route 30, but historical data would indicate that that entrance has been there for some time. GHI comments dated January 23^{rd} , and March 25^{th} , along with YCPC comments dated March 25^{th} were touched on but will have to be addressed.

Until plan changes could be made, it was felt by all not to discuss the comments from GHI or YCPC. Tom Bosley then motioned and Mike Zeigler seconded, to postpone the plan. The motion passed.

9. Adjournment:

Having no further business, a motion was made by Bob Nivens to adjourn the meeting, seconded by Mike Zeigler. The meeting was adjourned at 8:00 PM.
