It was noted that township will sell Polaris ATV with proceeds being deposited into the Recreation Fund

 - 3) **Engineer:** Doug Stambaugh provided a written report showing engineering activities in January and February to date
 - 4) **Planning Commission:** Kevin Barnes provided an oral report, working on some existing projects with assistance of our Solicitor.
