APPROVE TREASURER'S REPORT: Clark Craumer made a motion to approve as read, 2nd by Dean Bentzel, approved by Unanimous Vote

 - d. **Beaver Creek RD...**No Update

- 2) Resolution 2021-07 establishing the Annual Budget, Realty Transfer, Tax, Amusement Tax, Earned Income Tax, and Real Estate Tax. All tax rates will remain the same from the previous year 2021. Dean Bentzel made a motion to approve Resolution 2021-07, 2nd by Clark Craumer, approved by Unanimous Vote
- 3) Resolution 2021-08, Approval of Tax Collector and Tax Collector Agreement... Dean Bentzel made a motion to approve Resolution 2021-08, 2nd by Clark Craumer, approved by Unanimous Vote
- 4) New Trash hauler Republic Services sent out initial mailers to residents from a mailing list compiled from tax payer records provided to them. The letter should arrive by December 20th and totes will be delivered the week following Christmas with the initial invoice to follow.

REPORTS:


- 1) **Emergency Management:** No report
